The Journal of Clinical Investigation (*JCI*) is a premier venue for research into the biomedical basis of disease and the clinical impact of this research on human health. The *JCI* is committed to the dissemination of the science it publishes through barrier-free online access, and it strives to provide authors with fair and equitable rights, as noted below, in return for assigning copyright of their work to the *JCI*'s publisher and owner, the American Society for Clinical Investigation (ASCI). In addition, the *JCI* asks each author, in order to protect the integrity of the published work, to warrant their contribution to the published work and to disclose any financial relationship that could be construed as a conflict of interest.

Each author must read and sign the statements on (1) authorship responsibility, (2) financial disclosure, and (3) copyright. This document may be copied to distribute to coauthors for signature. Fax all copies to 734-222-6058 after the manuscript is accepted and prior to publication.

Authorship responsibility. I certify that I have participated sufficiently in the conception and design of this work and the analysis of the data (where applicable and within my area of expertise), or the writing of the manuscript, and to take public responsibility for it. I warrant that my work is original and scientifically accurate, that it is not defamatory, does not invade any right of privacy, and does not infringe on any proprietary right or copyright. I agree to indemnify and hold the ASCI and the *JCI* harmless against any claim to the contrary. I believe the manuscript represents valid work. I have reviewed the final version of the manuscript and approve it for publication. To my knowledge, neither this manuscript nor one with substantially similar content under my authorship has been published or is being considered for publication elsewhere, except as described in an attached letter. I attest that I shall produce the data on which the manuscript is based for examination by the editors or their assignees should they request it. Finally, I certify that I have obtained written permission from all persons named in unpublished observations or the acknowledgments.
